**To apply, the following is required:**

- **A COSIGNER** is a person who agrees to be liable for another person's debt, or for the performance of another's duty, liability, or obligation.
- **A COSIGNER** must be 18 years of age or older.
- If approved, the cosigner understands and agrees they are liable for the entire amount of the rent and any damages incurred by tenants.
- It is required that the cosigner application be filled out on both pages, and signed by the cosigner on page 2 of this application. If there are multiple cosigners, a cosigner application is required for each party.
- An application/processing (**non refundable**) fee of \$45.00 per applicant is required to process applications, no exceptions, and must accompany this application.
- RPM reviews income, credit, rental, or home ownership to qualify applicants.
- **A COSIGNER** must be able to support their current obligations and that of the tenants for whom they are cosigning.
- **A COSIGNER** guarantees the applicant (s) has disclosed all animals/pets on their rental application, and cosigners are liable for any damages caused by animals/pets.
- **A COSIGNER** guarantees the applicant (s) has disclosed all vehicles of any size, kind, or type, such as automobiles, RV's, boats, motorcycles, etc., on their rental application.
- Applicant (s) and cosigner (s) must disclose all water-filled furniture for the property and the applicant (s) and cosigner (s) bears responsibility for the required insurance.
- RPM processes cosigner application (s) in 3 to 5 business days. Applications can take longer if more information is required from the cosigner, or that of a reference on this application.
- RPM Agent and/or the owner must approve all cosigner information.

**If Real Property Management (RPM) approves the applicant (s)/cosigner (s):**

- If RPM approves the cosigner (s), to hold a property and refuse other applicants, the applicant (s) and/or cosigner must pay the first month's rent in CERTIFIED FUNDS, and the rental agreement must be signed by both cosigner and applicant (s). The applicant (s) and/or cosigner must pay the security deposit in CERTIFIED FUNDS, in full prior to the commencement of the rental agreement.
- All cosigners and applicants, 18 and over, must sign the rental agreement, and supply a current ID at time of signature.
- If the approved cosigner (s)/applicant (s) defaults on renting the property, paying the necessary funds, and signing a Rental/Lease Agreement, RPM reserves the right to deny all applications involved.
- If approved, RPM completes a walk through inspection prior to occupancy.

**If Real Property Management (RPM) denies applicant (s)/cosigner (s):**

- RPM will notify cosigner (s) and applicant (s) of denial as soon as practical.
